SPEAKER BIOGRAPHIES



EDWARD ABRAHAM

Executive Vice President for Health Affairs; Chief Executive Officer, UHealth; Professor, Dean & Chief Academic Officer UM Leonard M. Miller School of Medicine

Dr. Edward Abraham received both his undergraduate and medical degrees at Stanford University and trained in internal

and critical care medicine at the University of California, Los Angeles (UCLA). He was a Fulbright Postdoctoral Fellow in the Laboratory of Immunobiology at the Pasteur Institute in Paris. After completing his training, Dr. Abraham joined the faculty at UCLA, where he was Associate Director of the Division of Pulmonary & Critical Care Medicine, Program Director of the Multi-Hospital Critical Care Training Program, Chief of Critical Care Services in the Division of Pulmonary & Critical Care Medicine, and Associate Professor in the Department of Medicine. In 1993, Dr. Abraham moved to the University of Colorado Health Sciences Center in Denver. His numerous leadership roles during 13 years at the University of Colorado Health Sciences Center included Program Director of the Critical Care Medicine Fellowship, Vice Chair for Administrative Affairs in the Department of Medicine, Director of the Division of Pulmonary Sciences and Critical Care Medicine, Roger Sherman Mitchell Professor of Pulmonary and Critical Care Medicine, and Vice Chair of the Department of Medicine. In 2006, Dr. Abraham moved to the University of Alabama at Birmingham (UAB) as Spencer Chair in Medical Science Leadership and Chair of the Department of Medicine. During his five years as chair of medicine at UAB, the department increased research funding by 25 percent, developed a physicianscientist track in the residency program, initiated a mentoring program for junior faculty, enhanced diversity among faculty and trainees, and fostered a culture of collaboration and teamwork among faculty and staff. Dr. Abraham served as Dean of Wake Forest School of Medicine from 2011 through 2017.



HUDA ABU-SAAD HUIIER

Professor & Director, Hariri School of Nursing, American University of Beirut

Dr. Abu-Saad Huijer is professor and Director of the Hariri School of Nursing at AUB. Her research endeavors have focused primarily on pain management and palliative care in children and adults. To that

effect she has supervised a large number of PhD dissertations and has been lead investigator on a large number of funded projects in the Netherlands and in Lebanon on pain management, palliative care, and integrated models of care for the chronically ill. Her research endeavors in Lebanon have focused primarily on pain management & palliative care in adults and children. She is currently a lead investigator on a number of national projects and has published more than 300 articles in national & international refereed and professional journals and two books, one of which

is on evidence-based palliative care across the life span. Dr. Abu-Saad Huijer was elected International Fellow to the American Academy of Nursing and is a fellow and founding member of the European Academy of Nursing Science. Dr. Huijer received many awards & recognitions for her work in PR & PC: Life Time Achievement Award from the McMillan Cancer Fund and the International Journal of Palliative Nursing in London; High Achievement Award from the American University of Beirut Alumni Nurses Chapter; Pioneers Award from the Order of Nurses in Lebanon; and distinguished researcher award from the Scientific Society of Arab Nursing Faculties. More recently she was inducted into the Sigma Theta Tau International Nurse Researcher Hall of Fame, awarded the International Association for the Study of Pain Honorary membership, and received the Princess Mona Regional Award for her significant contribution to the nursing profession.



ZIPPORAH ALI

Executive Director, Kenya Hospices and Palliative Care Association (KEHPCA)

Dr. Zipporah Ali is the Executive Director or of Kenya Hospices and Palliative Care Association (KEHPCA). She serves on the board of several organizations including; International Children's Palliative Care

Network, Worldwide Palliative Care Alliance and Youth Against Cancer in Kenya. Zipporah is involved in advocacy and creating awareness on pain relief and palliative care in Kenya for children and adults. In her leadership role as the Executive Director for KEHPCA, she has been instrumental in fostering strong relationships with the Ministry of Health to integrate palliative care into government hospitals. She has also been instrumental in advocating for palliative care to be integrated in undergraduate medical and nursing schools in Kenya. Zipporah holds an MD from Ege University, Izmir, Turkey, a Master's Degree in Public Health from the University of Nairobi, a Higher Diploma in Palliative Care from Oxford Brookes University and a Masters in Palliative Care from the University of Dundee. She has completed the International Pain Policy Fellow program with the International Pain Policy Studies Group (WHO Collaborating Centre for Policy and Communication in Cancer Care, University of Wisconsin) as well as the International Palliative Care Leadership Development Initiative at The Institute of Palliative Medicine at the San Diego Hospice. In 2012, Zipporah was awarded an Honorary Doctor of the University by Oxford Brookes University in recognition of her outstanding contribution in palliative care both internationally and locally. SIR GEORGE ALLEYNE

Director Emeritus, Pan American Health Organization; Board Member, NCD Alliance; Commissioner, WHO Independent High-Level Commission on NCDs

Sir George Alleyne, a native of Barbados is a medical graduate of the University of the

West Indies (UWI) where he subsequently pursued an academic career. He worked under Professor John Waterlow in the Tropical Metabolism Research Unit at UWI on the pathophysiology of infant malnutrition and on several aspects of renal intermediary metabolism. He was appointed Professor of Medicine in UWI in 1972 and chair of the Department of Medicine in 1976. He joined the Pan American Health Organization (PAHO), Regional Office of the World Health Organization (WHO) in 1981, became Director on 1 February 1995 and after re-election in 1998, completed a second four-year term on 31 January 2003. In 2003 he was elected Director Emeritus of PAHO. From February 2003 until December 2010 he was the UN Secretary General's Special Envoy for HIV/AIDS in the Caribbean. From 2003 to 2017 he was Chancellor of the University of the West Indies and was a visiting professor at the Bloomberg School of Public Health, Johns Hopkins University also from 2003 to 2017. Sir George has received numerous awards in recognition of his work, including honorary degrees and prestigious decorations and national honors from many countries of the Americas. In 1990, he was made Knight Bachelor by Her Majesty Queen Elizabeth II for his services to Medicine. In 2001, he was awarded the Order of the Caribbean Community, the highest honor that can be conferred on a Caribbean national. He is married to Sylvan Chen and they have three children.



RIFAT ATUNProfessor of Global Health Systems,
Harvard University

Dr. Rifat Atun is Professor of Global Health Systems at Harvard University. He is the Faculty Lead for the Harvard Ministerial Leadership Program. In 2008-12 he was a member of the Executive Management

Team of the Global Fund as the Director of Strategy, Performance and Evaluation. In 2006-13 he was a Professor of International Health Management and Head of the Health Management Group at Imperial College London. Professor Atun's research focuses on health system reform and innovation in global health systems. He has published around 300 papers in leading journals, including in the New England Journal of Medicine, the Lancet, Lancet Oncology, Lancet Diabetes and Endocrinology, Lancet Global Health, Science Translational Medicine, Health Affairs, and the Academy of Management Journal. Dr. Atun has worked at the UK DFID's Health Systems Resource Centre and has acted as a consultant for the World Bank, WHO, and with many governments to design, implement and evaluate health system reforms. He has undertaken assignments for and acted in a consulting or advisory capacity to leading organizations, including Medtronic, Novartis, Merck & Co, MSD, Pfizer and Roche. Professor Atun has served as a member of the US National Academy of Medicine Standing Committee on Health Systems, PEPFAR Scientific Advisory Board, and the Advisory Boards of WHO Research Centre for Health Development in Japan, and Norwegian Research Council's Programme for Global Health and

Vaccination Research. He is a member of the UK Medical Research Council's Global Health Group. He is a member of the Longitude Prize Committee, the largest science prize in the world. Professor Atun studied medicine at University of London as a Commonwealth Scholar and completed his postgraduate medical training in family medicine and public health, and Masters in Business Administration at University of London and Imperial College London. He is a Fellow of the Royal College of Physicians (UK), a Fellow of the Faculty of Public Health (UK), and a Fellow of the Royal College of General Practitioners (UK).



AFSAN BHADELIA

Research Associate, Department of Global Health and Population at the Harvard T.H. Chan School of Public Health

Afsan Bhadelia, PhD, MS is a Research Associate in the Department of Global Health and Population at the Harvard T.H. Chan School of Public Health, and a

Visiting Scholar at the University of Miami Institute for Advanced Study of the Americas. Dr. Bhadelia conducts health systems research focusing on chronic care management, particularly on cancer and palliative care, and analysis on the development of comprehensive metrics for priority-setting in health that seek to incorporate the dimension of ethics. Dr. Bhadelia was one of the lead authors of the report of the Lancet Commission on Global Access to Palliative Care and Pain Relief and co-Chaired the Commission's Scientific Advisory Committee. Between 2009 and 2015, she held various research roles at the Harvard Global Equity Initiative, including Research Director and Director of the Women and Health program. She previously coordinated the Global Task Force on Expanded Access to Cancer Care and Control (GTF.CCC), and co-authored and co-edited the GTF.CCC's book, "Closing the Cancer Divide: An Equity Imperative," distributed by Harvard University Press. She was selected by the Union for International Cancer Control as a Young Cancer Leader in 2015 for her on-going contributions to cancer disparities. Dr. Bhadelia holds a PhD from the Johns Hopkins Bloomberg School of Public Health, focusing on health systems, bioethics, and health economics. She has a MS from the Friedman School of Nutrition Science and Policy and a BS in Biology and International Relations from Tufts University. She is currently Adjunct Faculty at the Public Health Foundation of India.



SUSHMA BHATNAGAR

Prof and Head, Dept of Onco-Anaesthesia and Palliative Medicine, Institute Rotary Cancer Hospital; President of the Indian Association for Palliative Care

Sushma Bhatnagar has 30 years of teaching and research experience, with

research interest in Cancer Pain Management and Palliative Care. She is member and coordinator of the National Palliative care program, India, and was the Chief Editor of the Indian Journal of Palliative Care, and IASP Council member in 2016 for the duration of six years. She is on the Board of Directors for the International Association of Hospice and Palliative Care. Her awards include the Leadership and Excellence Award amongst SAARC, and the IASP Award for Excellence in Clinical Research or Practice and/or Policy Changes in Pain Management in the Developing World. She has authored over 150 publications.



JIM CLEARY

Professor of Medicine, University of Wisconsin School of Medicine and Public Health; Director, Pain and Policy Studies Group, WHO Collaborating Center for Pain Policy and Palliative Care

A graduate of University of Adelaide Medical School, South Australia, Dr.

Cleary trained in Internal Medicine and Medical Oncology at the Royal Adelaide Hospital followed by three years of opioid pharmacology research. He moved to Wisconsin, where he served as the founding Medical Director of the Palliative Care Clinical Program from 1996-2011. He also served as Program Director of Cancer Control at the UW Carbone Cancer Center, integrating palliative care into that program and Chair of the UWCCC's Scientific Review Committee. He was the 2004 President of the American Academy of Hospice and Palliative Medicine and serves as a North American Editor of Palliative Medicine, the Research Journal of the European Association of Palliative Care. He became Director of the Pain and Policy Studies Group in 2011 and co-lead the Global Opioid Policy Initiative that reviewed opioid availability in Africa, Asia, the Caribbean and Latin America, India, and the Middle East. He was co-chair of the Breast Health Global Initiative (BHGI)'s resource stratified guidelines for Palliative Care and is currently a member of the WHO Cancer Pain Guideline Committee, the Lancet Commission on Palliative Care and is co-chair of ASCO's Resource-Stratified Guideline on Palliative Care. He was honored recently as one of 30 global Visionaries in Palliative care by the American Academy of Hospice and Palliative Care. He will be leaving the UW in July, to commence work as Director

He will be leaving the UW in July, to commence work as Director of Supportive Oncology at the Indiana University Simon Cancer Center holding the Walther Senior Professorship in Supportive Oncology at IU.



LILIANA DE LIMA

Executive Director, International Association for Hospice and Palliative Care (IAHPC)

Liliana is a native of Colombia, South America and currently living in Texas, USA. Her academic background is in psychology with post graduate degrees in clinical psychology and in health care

administration, She completed a fellowship in pain and policy studies at Pain and Policy Studies Group at the University of Wisconsin. Previously held positions include coordinator and director of Hospice La Viga in Colombia and director of international programs in the Palliative care department, MD Anderson Cancer Center in Houston. She is one of the founders of the Latin American Association for Palliative Care (ALCP) and was its President from 2004 to 2010. Since August 2000 she has been the Executive Director of the International Association for Hospice and Palliative Care (IAHPC) and in this capacity, she has worked with institutions and government representatives to advance palliative care both locally and internationally. She has served in the World Health Organization Expert Committee on Drug Dependence and the Expert Committee on the selection and use of Essential Medicines. She received awards from the State of Texas Traineeship for high scholastic achievement and Phi Kappa Phi Honor Society certificate of recognition for high scholastic achievement. In 2014 she was awarded the John Loeser Award

from the International Association for the Study of Pain (IASP) and in 2017 she was awarded the Florian Award for substantial contributions to improving pain management and quality of life in terminal patients by advancing hospice and palliative care programs, education and research around the world.



JULIA DOWNING

Prof Julia Downing, Chief Executive, International Children's Palliative Care Network

Professor Downing is an experienced palliative care nurse, educationalist and researcher. She has been working within palliative care for 26 years, with seventeen

of those working internationally including in Uganda, across Africa, Eastern Europe and throughout the world developing palliative care services for adults and children. She is recognised as a global leader and expert in the field of palliative care development, speaking and sharing regularly on this topic. She also directed the Open Society Foundation's Project on Death in America, a nine year 45 million dollar effort, to transform the culture of dying in the US and served as the medical director of OSF's International Palliative Care Initiative which funded international efforts to advance palliative care in low and middle income countries. Dr. Foley is a member of the

Julio Frenk is a renowned scholar and leader in higher education and global health who is deeply committed to promoting the crucial role universities play in advancing knowledge to address global challenges. He

became President of the University of Miami in 2015 and holds academic appointments as Professor of Public Health Sciences at the Leonard M. Miller School of Medicine and Professor of Health Sector Management and Policy at the School of Business Administration. He previously served as Dean of the Harvard T.H. Chan School of Public Health, and as Minister of Health of Mexico, he reformed the nation's health system, introducing a program of comprehensive universal coverage, which expanded access to health care for more than 55 million previously uninsured Mexicans. He is the founding Director-General of the National Institute of Public Health of Mexico and has held top positions at the World Health Organization and the Bill and Melinda Gates Foundation, among others. He holds an M.D. from the National University of Mexico, and a master of public health and joint Ph.D. in Medical Care Organization and Sociology from the University of Michigan. He has received numerous honorary degrees and authored more than 170 articles and 30 books. He is on the boards of the United Nations Foundation and the Robert Wood Johnson Foundation, and is a member of the American Academy of Arts and Sciences, U.S. National Academy of Medicine, National Academy of Medicine of Mexico, and El Colegio Nacional of Mexico.

CYNTHIA GOH

Chair, Asia Pacific Hospice Palliative Care Network; Senior Consultant, Division of Supportive & Palliative Care, National Cancer Centre Singapore/Singhealth; Associate Professor, Duke-NUS Graduate Medical School

Dr. Cynthia Goh is Senior Consultant in the Division of Supportive and Palliative Care at the National Cancer Centre Singapore and Associate Professor at the Duke-NUS Graduate Medical School. She is an accredited specialist in Internal Medicine and Palliative Medicine and has a PhD in Biology. From 1986, she helped several community palliative care services, for which she was awarded the Public Service Medal in 1997. In 1999, she started the first Department of Palliative Medicine in Singapore at the National Cancer Centre, and headed it till 2011. This led to establishment of palliative care services all government hospitals, and Palliative Medicine to be recognised as a medical subspecialty in 2006. She established the Chapter of Palliative Medicine at the College of Physicians Singapore in 2011. She chairs the Palliative Medicine Subspecialty Training Committee of the Specialist Accreditation Board. Dr. Goh was President of the

Pain Association of Singapore from 2001 to 2005 and Founding President of the Association of South East Asian Pain Societies from 2004 to 2007. She was Council member of the International Association for the Study of Pain from 2008 to 2014. She helped found the Worldwide Hospice Palliative Care Alliance (WHPCA) and co-chaired it from 2008 to 2014. Dr. Goh currently chairs the Asia Pacific Hospice Palliative Care Network (APHN) and was involved in its formation since 1996. Her major interests are to help build capacity for palliative care in countries like Bangladesh, Myanmar, Sri Lanka and India.



PASCAL GOLDSCHMIDT

Dean Emeritus and Professor of Medicine Emeritus of UM Miller School of Medicine

Pascal J. Goldschmidt, MD, an internationally renowned cardiologist and cardiovascular researcher, is currently overseeing large-scale international healthcare projects, and is Dean and Professor of Medicine Emeritus of the

University of Miami Leonard M. Miller School of Medicine, and founding CEO of the University of Miami Health System, UHealth. Dr. Goldschmidt oversaw tremendous growth in Miami, with the 2007 purchase of the University of Miami Hospital, flagship hospital of UHealth. A firm believer in global health, Dr. Goldschmidt led a team to oversee the medical relief effort in Haiti after the January 2010 earthquake. Today, Dr. Goldschmidt is developing and leading the first American Healthcare System of Western Africa, starting in Marrakech Morocco, a massive undertaking which will elevate healthcare in the entire region. An NIH funded investigator for his entire academic career, he continues to publish his work in top scientific journals, and has created 15 centers and institutes at UM, including of the John P. Hussman Institute for Human Genomics, the Dr. John T. Macdonald Foundation Biomedical Nanotechnology Institute at UM (BioNIUM), and the Interdisciplinary Stem Cell Institute, all led by world renowned scientists. Dr. Goldschmidt, whose research applies genomics and cell therapy to prevention, diagnosis and treatment of coronary artery disease, was previously chairman of the Department of Medicine at Duke University Medical Center. A native of Belgium, Dr. Goldschmidt received degrees and training from the Université Libre de Bruxelles, Erasme Academic Hospital, Union Memorial Hospital and The Johns Hopkins University, where he also served as assistant, then associate professor in the JHU's Division of Cardiology, Department of Medicine until 1997.



MARY GOSPODAROWICZ

Medical Director, Princess Margaret Cancer Centre; Professor, University of Toronto

Mary Gospodarowicz is University Professor at the University of Toronto, Medical Director of Princess Margaret Cancer Centre/University Health Network, and the Regional Vice President of Cancer Care Ontario. She is past

Chair of Department of Radiation Oncology at the University of Toronto. Her research focused on clinical trials evaluating radiation therapy, image-guided precision radiotherapy, and cancer survivorship. Her current interests include global cancer control, global access to radiotherapy, and quality cancer care. She is a Past-President of the Union for International Cancer Control (UICC). She participated in the Global Task Force on Cancer Care and Control of HGEI and the HGEI-Lancet

Commission on Global Access to Pain Control & Palliative Care. Under the auspices of UICC and Lancet Oncology, the Global Task Force on Radiotherapy produced a seminal report on "Expanding the global access to radiotherapy" that provided evidence for the demand, efficacy, and cost-effectiveness of radiotherapy. She is a Fellow of the American Society in Radiation Oncology (ASTRO), Honorary Fellow of the Royal College of Radiologists in the United Kingdom, Honorary Fellow of the Faculty of Radiologists in the Royal College of Surgeons of Ireland, and honorary member of ESTRO, SASRO, and DEGRO. She is a recipient of the ASTRO Gold Medal, American Radium Society Janeway Medal, O. Harold Warwick Prize from Canadian Cancer Society, and the Women Who Conquer Cancer Mentorship Award from the American Society of Clinical Oncology. She was appointed Officer of the Order of Canada in 2015.



ANDREW W. GURMAN Immediate Past President, American Medical Association

Andrew W. Gurman, MD, an orthopaedic hand surgeon from Hollidaysburg, Pa., was the 171st president of the American Medical Association. Prior to becoming AMA president in June 2016, Dr. Gurman was an

active and highly visible member of the AMA Board of Trustees, and both speaker and vice speaker of the AMA House of Delegates during a period of change and refocus for the organization. In August 2016 Dr. Gurman was named one of Modern Healthcare magazine's 100 Most Influential People in Healthcare (No. 27). As the first hand surgeon and only the second orthopaedic surgeon to have served as AMA president, Dr. Gurman believes strongly that nurturing the profession is crucial for America's physicians and the generation who will one day take their place. Born in New York City and raised in Mount Vernon, N.Y., Dr. Gurman is a graduate of Syracuse University. He received his medical degree from the State University of New York Upstate Medical University, Syracuse, in 1980. Dr. Gurman's advocacy work in medicine began early as a student delegate to the AMA Student Business Session, precursor to the AMA Medical Student Section of today. After completing his surgical internship and residency in orthopaedic surgery at the combined Montefiore Hospital/Albert Einstein program in New York City, and a fellowship in hand surgery at the Hospital for Joint Diseases Orthopaedic Institute, Dr. Gurman entered practice in central Pennsylvania and became active in the local medical society and civic organizations.



RICHARD HARDING

Professor Richard Harding, Herbert Dunhill Chair in Palliative Care & Rehabilitation, Director of the Centre for Global Health Palliative Care, Cicely Saunders Institute, Kings College London

Professor Harding leads the Centre for Global Health Palliative Care and the WHO

Collaborating Centre for Palliative Care at the Cicely Saunders Institute. His research programme focuses on Europe, sub-Saharan Africa and the Middle East, and he leads the palliative care work streams in several UK overseas development agency-funded Global Challenge Research Funds programmes. He currently holds a European Research Council Consolidator Award to

translate scientific advances in paediatric palliative care from sub-Saharan Africa to the UK. Professor Harding's primary research interest is how to develop and test person-centred health services through health systems strengthening, and the routine implementation of person-centred outcome measures to improve assessment and outcomes. His current research is addressing health in conflict, paediatrics, COPD, cancer, HIV, pain self-management, renal failure, LGBT patients, communication, development of apps for patient empowerment and data transfer, and bereavement outcomes.



RICHARD HORTONEditor-in-Chief, The Lancet

Richard Horton is Editor-in-Chief of *The Lancet*. He was born in London and is half Norwegian. He qualified in physiology and medicine with honours from the University of Birmingham in 1986. He joined *The Lancet* in 1990, moving to New York as

North American Editor in 1993. Richard was the first President of the World Association of Medical Editors and he is a Past-President of the US Council of Science Editors. He is an honorary professor at the London School of Hygiene and Tropical Medicine, University College London, and the University of Oslo. He has received honorary doctorates in medicine from the University of Birmingham, UK, and the Universities of Gothenburg and Umea in Sweden. In 2016, he was appointed to the High-Level Working Group for the Health and Human Rights of Women, Children, and Adolescents. In 2016, he also chaired the Expert Group for the High Level Commission on Health Employment and Economic Growth, convened by Presidents Hollande of France and Zuma of South Africa. From 2011 to 2015, he was co-chair of the UN's independent Expert Review Group on Information and Accountability for Women's and Children's Health. Richard received the Edinburgh Medal in 2007 and the Dean's Medal from Johns Hopkins School of Public Health in 2009. In 2016, he was awarded an Honorary Fellowship by the British Pharmacological Society. He has written two reports for the Royal College of Physicians of London: Doctors in Society (2005) and Innovating for Health (2009). He wrote Health Wars (2003) about contemporary issues in medicine and health, and he has written for The New York Review of Books and the TLS. He has a strong interest in global health and medicine's contribution to our wider culture. He now works to develop the idea of planetary health the health of human civilizations and the ecosystems on which they depend. In 2011, he was elected a Foreign Associate of the US Institute of Medicine. In 2015, he received the Friendship Award from the Government of China. In 2016, he received the Andrija Stamper medal from the Association of Schools of Public Health in the European region and in 2017, he was awarded the Edwin Chadwick Medal for outstanding contributions to the advancement of public health.



DEAN T. JAMISON

Dean T. Jamison is Emeritus Professor in the Institute for Global Health Sciences at the University of California, San Francisco. In addition to UCSF, Dean has been with UCLA

the Leonard M. Miller School of Medicine. She is also a Full Member of Sylvester Comprehensive Cancer Center. From 2009-2015, Dr. Knaul served as Associate Professor at Harvard Medical School and Director of the Harvard Global Equity Initiative. A health and social sector economist who has worked extensively in Latin America and the Caribbean, Dr. Knaul maintains a strong program of research and advocacy in the region, especially in Mexico, where she is the Senior Economist at the Mexican Health Foundation. She is also the Founding President of Tómatelo a

Pecho, a Mexican NGO that undertakes and promotes research, advocacy, awareness, and early detection initiatives for breast cancer in Latin America. Her research focuses on global health, health financing, health systems and reform, cancer and especially breast cancer in low- and middle-income countries, access to pain control and palliative care, poverty and inequity, and gender equity. In recent years, he has served as Medical Officer for Palliative Care at WHO headquarters in Switzerland, on the Lancet Commission on Global Access to Palliative Care, and on the Board of Directors of the International Association for Hospice & Palliative Care. He has published numerous scientific papers and textbook chapters on clinical and ethical issues in palliative care and on implementing palliative care in LMIC.



RÜDIGER KRECH

Director, Universal Health Coverage and Health Systems, World Health Organization

Dr. Rüdiger Krech is the Director for Universal Health Coverage and Health Systems at the World Health Organization. The cluster of Universal Health Coverage (UHC) covers WHO's work in the areas of

integrated people-centered health services, health workforce, financing and health governance. As his function is positioned in the Assistant Director-General's Office, he acts on behalf of, and represents her in meetings, committees and other events and

facilitates coordination and coherence between the health systems work of the Organization and other areas of public health. He is the cluster's focal point for the WHO transformation, in particular on issues relating to WHO leadership priorities, governance and management. Before that, Dr. Krech was the Director of the Department of Ethics, Equity, Trade and Human Rights at the World Health Organization from 2009 to 2012. In this capacity, he was also responsible for WHO's work on Social Determinants of Health and Health in All Policies. Before joining WHO, he was in charge of German International Cooperation's (GiZ) work on social protection from 2003-2009 both in its Headquarters in Eschborn near Frankfurt and in India. He has also held various management positions at the World Health Organization Regional Office for Europe in Copenhagen in the fields of health systems, health policies, health promotion and ageing between 1992-2003. Dr. Krech has studied educational sciences, medicine and public health, and holds a Master's and a Doctoral degree in public health.



DIEDERIK LOHMAN

Director, Health and Human Rights Division, Human Rights Watch

Diederik Lohman is the Director of the Health and Human Rights Division at Human Rights Watch. He oversees the organization's work on health rights and the rights of older people. He led the organization's research

and advocacy on palliative care and pain treatment, spearheading advocacy at the U.N. Commission on Narcotic Drugs, the International Narcotics Control Board, the World Health Organization and other international institutions. He is also the founder of Stichting Russian Justice Initiative, an organization dedicated to helping victims of serious human rights violations perpetrated in the Chechen and other conflicts in the former Soviet Union seek justice.



GILBERTO LOPES

Associate Professor of Clinical Medicine, Medical Director for International Programs, Associate Director for Global Oncology, Sylvester Comprehensive Cancer Center, UM Miller School of Medicine

Gilberto Lopes, a medical oncologist, is the medical director for international programs

and associate director for Global Oncology at the University of Miami Sylvester Comprehensive Cancer Center and associate professor at the Miller School of Medicine; and associate editor for ASCO University and for the society's Journal of Global Oncology; he previously worked at the Johns Hopkins University and was chief medical and scientific officer for the Oncoclinicas Group, the largest oncology provider in Latin America with 35 clinics and more than 300 oncologists in nine states in Brazil. He has published more than 100 papers in journals such as the Journal of Clinical Oncology, Cancer, Nature

Reviews, Lancet, Lancet Oncology and Health Affairs. In addition to delivering lectures around the world, he has been principal, co-Principal Investigator or steering committee member in more than 100 studies and clinical trials covering breast, gastrointestinal, genitourinary and thoracic cancers. His other main areas of research interest are health economics, value, policy and access to cancer drugs and treatment in low- and middleincome countries. He is currently a committee member for the International Association for the Study of Lung Cancer, a member of the European Society of Medical Oncology expensive, innovative Medicines working group and the chair for the international clinical trials workshop working group and track leader for global health at ASCO, as well as an executive board member for the Latin American Cooperative Oncology Group. He has also served as an expert for the International Atomic Energy Agency, WHO and PAHO, and advised governments, professional societies and industry on issues related to cancer control and treatment in low- and middle-income countries.



SILVANA LUCIANI

A/unit chief, noncommunicable diseases and Advisor, cancer prevention and control, Department of Noncommunicable Diseases and Mental Health, Pan American Health Organization

Silvana Luciani is a public health professional who has led international and

national health programs on cancer prevention and control, tobacco control, and nutrition. At the Pan American Health Organization, she is working with Ministries of Health in Latin America and the Caribbean to better understand the burden of noncommunicable diseases (NCD) and to establish evidencebased NCD programs. Dr. Ntizimira has been a critical part of the post-conflict rebuilding of Rwanda's health system following the 1994 genocide against Tutsi as Director of Kibagabaga District Hospital in Kigali and contributed to the implementation of the national policy of palliative care at community level in Gasabo district become a model of care in Rwanda. A Palliative Care Expert and Educator, Dr. Ntizimira pioneered integration of end of life care into health services rendered to Rwandan patients with chronic illnesses in acute care and community settings. Through his

program (2008-2013), more than 1500 health care providers and community health workers have learned the risk factors of cancer & concept of palliative care leading to a five-fold increase in prescription of morphine, an essential pain medication. He Dr. Ntizimira is a former Researcher collaborator at Harvard Global Equity Initiative - Lancet Commission on Global Access to Pain Control and Palliative Care (GAPPCP).
